CFLRP: Collaborative Role

- Pursuant to the CFLRP award an All Lands collaborative effort has sprung up to try to coordinate actions on public lands with efforts that have been ongoing on private lands for years. The coordinators of that effort invite the NBFC to describe their role in this effort so that others can better understand how we fit in with the other people working in this arena.

Caitlin Rushlow

- The Wallowa County NRAC presentation of the DRAFT new Natural Resources Plan
- See slide show & new Plan
- Over twenty years ago, the NRAC emerged in response to the ESA listing of the spring Chinook Salmon. Their first project was a "Salmon Plan" co-authored by the County and the Nez Perce Tribe. This process was an update of that 90's era Plan.
- It provides advice, and shows where resources may exist to help upgrade management practices. It is not a regulatory document. It will become part of the Wallowa County Comprehensive Land Use Plan.
- Since the Plan was passed in the 90's it's been the touchstone for attracting millions of dollars to the local area for habitat restoration. There is more high quality habitat in Wallowa County than is being occupied. The problem is that the fish are having a hard time getting to Wallowa County.
- There is a very strong emphasis on monitoring to verify that the good ideas are happening.

- Wallowa County NRAC has existed for over 25 years. Aiming to create a comprehensive and complete database of all projects they've worked on
- Kathleen Cathey suggested that they should talk about some innovative work they did with Malheur County re: salmon; that there might be opportunities.

Zones of Agreement
